Louisiana Saturday Night: Our hosts graciously will offer **COCHON DE LAIT** for dinner Saturday night. A traditional Cajun dish, this whole roasted "milk-fattened" pig will be accompanied by trimmings and fixings provided by GPLA. Again, a small fee will cover expenses and all will be well fed.

Box Training and Practice: If your Whippet has not seen the boxes for a while, you may want to postpone entering the meet Saturday and get in a practice session first. Play Sunday by ear and keep the big picture in mind when deciding if your Whippet is ready for competition. Practice will follow Saturday's races.

Directions to Site: From I-12 East or West—Take Exit 63B onto Hwy 190 toward Covington. Get in right lane after Wendy's on Hwy 190. Turn right on Hwy 21 (between Walgreen's & Rouse's Supermarket) going toward Bogalusa. Travel about 7 miles, turn LEFT on Hwy 1083 NORTH, go 2-1/2 miles, cross a small bridge and turn LEFT on Fauntleroy Road. Next LEFT will be Chat Blanc Ln—the field is at the end of Chat Blanc Ln.
